Meeting Minutes of Regular Session Tuesday, February 20, 2024

The New Cordell City Council met at the Cordell Community Center at 101 East Main behind City Hall on Tuesday, February 20, 2024 with seven council members present including: Blake Reed, Sheri Parsons, Greg Cox, Bruce Wesner, Tad Boone, Earlene Smith, and Cheri Nabors. Also present were Mayor Phil Kliewer, City Attorney Shane Regier, Interim City Administrator Vicki Hagerman, and City Clerk Karla Ferrero. Council member Lowell Holman was absent. The agenda was posted on Friday, February 16, 2024 before 5 pm in the front window of City Hall.
