Meeting Minutes of Special Session Monday, September 25, 2023

The New Cordell City Council met in Special Session at the Cordell Community Center at 101 East Main behind City Hall on September 25, 2023 with eight council members present including: Blake Reed, Sheri Parsons, Greg Cox, Bruce Wesner, Lowell Holman, Tad Boone, Earlene Smith, and Cheri Nabors. Also present were Mayor Phil Kliewer, City Attorney Shane Regier, Interim City Administrator Vicki Hagerman, and City Clerk Karla Ferrero. The agenda was posted on Friday, September 15, 2023 before 5 pm in the front window of City Hall.

CALL TO ORDER, ROLL CALL AND DECLARATION OF A QUORUM:

Hagerman read the details of the proposal to Council. The total bid was for \$72,000.00 with an additional \$6,200.00 to replace the fountain at the Pocket Park on the Square. Significant discussion was held by Council and the Mayor regarding what would be planted in the flower beds, and the strategy for replanting them in regards to the timing of the Pumpkin Festival.

Council Member Smith made a motion to accept the proposal from Horse Creek Landscaping at \$72,000.00 with an additional \$6,200.00 to replace the fountain at the Pocket Park on the Square. Motion was seconded by Council Member Cox.

D. Consider, discuss and/or possible take action to Open and Accept Request for Proposal (RFP 23-02) 107 S Market St. (Mural Building) Demolition Project.

Two proposals were received. City Clerk Ferrero opened the envelopes and passed them to Interim City Administrator Hagerman to announce one at a time. The first proposal was from Midwest Wrecking for \$155,840.00 to demolish the building except the West wall with two options regarding the West wall: an additional \$10,420.00 to remove the West wall, or an additional \$8,250.00 to shore up the West wall. The second proposal was from K&M Dirt Services for \$426,528.00 to demolish the building except the West wall. Council asked if the City would have to pay the difference if they go with the shoring option and it falls down. City Attorney Regier stated that would likely come down to a clause in the contract about preservation of existing structures, which Hagerman confirmed was a parameter of the proposal. Council Member Parsons made a motion to accept the proposal from Midwest Wrecking at \$155,840.00 to demolish the building except the West wall with an additional \$8,250.00 to shore up the West wall. Motion was seconded by Council Member Boone.
