### TRUSTEE REMARKS:

Kliewer asked if the hospital could present reports to the city on a quarterly basis, Melinda Laird from the hospital agreed. Nabors asked about getting a trashcan like the ones around the square placed at the library, and informed the board that Rick Lindley had accepted the library board offer to replace Wood. Holman has a concern because the concessions and men's bathroom are not ADA compliant. He further stated that the Summer League had spent approximately \$2,500 to renovate the women's bathroom, and they would like some help covering the costs of the other renovation. He was not sure whether it was the Council or the School that he would need to approach. Kliewer suggested it may be a partnership and asked for a proposal for renovating the men's bathroom. Hagerman asked if there was still a portable handicapped stall on the site until renovations can be completed and was told there is. Holman mentioned that he would like to get some lights out there sometime. Kliewer stated that since the fields are near the airport, the FAA has strict requirements about lighting improvements. Parsons asked if since the renovation was only \$2,500 if it could be approved outside council.
