# Meeting Minutes of Regular Session Monday, June 12, 2023

The New Cordell City Council met at the Washita County Activity Center at 1005 East 3<sup>rd</sup> St. on June 12, 2023 with eight council members present including: Blake Reed, Sheri Parsons, Greg Cox, Bruce Wesner, Lowell Holman, Tad Boone, Earlene Smith, and Cheri Nabors.
